Proposed 2021 Budget Discussion Points – Henry Riely

We will ask the members to consider approving next year's proposed budget, which is attached on the next page. It assumes 2021 revenues and expenses of \$8,700 and \$10,195 respectively, for a net loss of \$1,495, which we can cover from our reserves. Some of the assumptions we made in preparing the budget are:

- a) Only the Shoreline Evaluation Program and the Teaching Gardens will continue their pre-pandemic level activities in 2021. Programs that have been cancelled due to the pandemic (including our Children's and Community Education programs and our participation in the Farmers Markets) will remain cancelled throughout next year.
- b) Our 2021 revenues will be substantially reduced because our major fundraiser, the GNN Seminar, will be held virtually at a charge of \$25, which is one-half of the amount we would charge for an inperson seminar.
- c) We will continue with members' annual dues of \$25, but we propose that those members who pay their dues by March 1 be allowed to participate in GNN without charge.
- d) We have also budgeted \$1,000 to pay for professional horticulturalists to speak at our monthly meetings, which we will resume next year on a virtual basis.
- e) We will continue to provide the \$1,000 college scholarship, \$1,000 to the four 4-H programs in the Northern Neck, \$500 to the EMG endowment and \$100 for memorials.

We will return to you next April or May with a revised 2021 budget for your consideration, when we will know GNN's results and hopefully have revised guidance from VCE on resuming our programs to pre-pandemic levels.
